

Purchasing in Switzerland

Mortgages

Swiss banks will lend up to 70% of the purchase price repayable over 25 years. Interest rates have always been among the lowest in Europe.

VAT rebate

VAT is not charged on the purchae of property in Switzerland.

Purchase costs and taxes in Switzerland

The total purchase costs (which include the notary's fee, land registry fees and taxes) vary from one canton to another in Switzerland. The various rates are:

Valais (Grimentz, 4 Vallees, Saas Fee, Verbier, Zermatt etc): 2.5% to 3.0% Bern (Wengen, Grindelwald): 3%

Vaud (Montreux, Villars): 5%

Graubünden (Davos-Klosters, Lenzerheide): 5%

Uri (Andermatt): 0.4%

The costs for registering a new mortgage also varies. In Vaud it is 0.5%. and in Valais 0.8% of the amount borrowed.

You do not pay notary fees when you sell - only the purchaser pays.
